\*\*Good progress has been made in the last weeks. We have a sharing understanding with Deborah Lang and Wendy Gladston. After working with the tapes Wendy understands the time commitment needed to get these on the web; both of them feel what we are doing on our web site is exactly what they have been talking about but not doing, from 4 years ago. So our efforts ow are to (1) convert their MP3s to our web site with all text; about 6-8 could be up on our site by Feb. 15th. (2) work on the 9 Redfield tapes to sort out the best ones, eliminate duplicates, and publish by Feb. 22. (3) we have picked up from Deborah about 26 more (and the final load) tapes and these are going to be put through the system in the coming weeks. Please NOTE: about 1/3 of the NH tapes so far are not for the STHS site due to poor quality of the interviews (sound etc.) and also topic (for example Parry Mansion centric.)
